- **5. STANDARDIZED TEST RESULTS** please include ACT and/or SAT scores in the application packet. Scores that appear on a sealed transcript or in a sealed envelope from a guidance counselor will be accepted.
- 6. **CANDIDATE FITNESS TEST** please provide a copy of a completed CFT. A form is available from the academies and the examination is to be administered by a high school coach or physical education teacher.
